


HOW TO CHANGE THE REMOTE'S BATTERIES

IF THE RED LIGHT ON THE REMOTE GLOWS DIMLY, OR FAILS TO LIGHT WHEN A BUTTON IS PUSHED, REPLACE THE REMOTE'S BATTERIES

- ① REMOVE VISOR CLIP AND SCREW




- ② CAREFULLY REMOVE THE CIRCUIT BOARD



- ③ INSTALL TWO TYPE 2016 BATTERIES PLUS (+) SIDE DOWN

- ④ REASSEMBLE THE UNIT WHEN FINISHED
